Acceptable General Waste loads under EWC code 200301:

- Non-Hazardous Mixed waste (more than 3 different elements) direct from the waste producer that can fall into the following common categories:
 - Municipal Solid Waste
 - Domestic Waste
 - Black Bag Waste
 - Trade Waste
 - Commercial & Industrial Waste
 - Residual Waste (from waste producer only) i.e. what's left that isn't recyclable.
 - All non hazardous dusty material must be double bagged
- For bins the waste must be compactable can include such things as dry unsorted waste, food contaminated packaging, floor sweepings, waste from litter bins, mixtures of paper, plastic, etc.
- For skips and roll on offs this can include such things as unsorted waste, food contaminated packaging, floor sweepings, waste from litter bins, mixtures of paper, plastic, wood and metals.

Examples of unacceptable types/items:

- Waste that is not "mixed" and all of the same thing e.g. A single stream waste from a production process or a full load of insulation or polystyrene etc as this should be categorised accordingly using the correct EWC code e.g. 170604 for non hazardous insulation.
- Hazardous waste such as:
 - Fridge Freezers/Electrical goods
 - Asbestos
 - Chemicals
 - Hazardous Chemical Containers
 - Batteries
 - Oils, Paint/Tins
 - Fluorescent Tubes
 - TV's/Monitors
- Certain items although not hazardous will be charged extra due to the difficult nature of handling and processing them such as:
 - Tyres
 - Insulation and foam in large quantities
 - Upholstered Items (sofas etc.)
 - Mattresses
 - Dusty material that is not double bagged
- Strictly no liquids such as drinks, inks, paints, oils even if non hazardous especially in bins as this will escape under compaction and possibly spill onto the floor.
- Unless in a skip or RORO, no large pieces of wood, metal or any brick/rubble etc as this can damage the compaction vehicle.

WHEREVER POSSIBLE REDUCE REUSE RECYCLE

Loads mixed with unacceptable materials will be rejected:

All loads will be inspected prior upon tipping. Any loads found to be contaminated will be deemed as unacceptable and rejected. The delivery driver will be informed and given evidence showing reason for the rejection.

All material must be consigned in accordance with the Duty of Care Regulations and the Environmental Protection Act and must be accompanied with the correct paperwork
